क्रमांक 105/छ.रा.वि.नि.आ./2023.— विद्युत अधिनियम 2003 (वर्ष 2003 का क्रमांक 36) की धारा 181 की उप धारा (2) (जेडके) सहपठित धारा 91 (2) एवं (3) में विहित प्रावधानों एवं पदत्त शक्तियों का प्रयोग करते हुए तथा छत्तीसगढ़ शासन के अनुमोदन से छत्तीसगढ़ राज्य विद्युत नियामक आयोग (छ.ग.रा.वि.नि.आ.) द्वारा छत्तीसगढ़ राज्य विद्युत नियामक आयोग (अधिकारियों एवं कर्मचारियों की नियुक्ति एवं सेवा शर्तें) विनियम-2005 बनाया गया। छत्तीसगढ़ शासन, ऊर्जा विभाग के पत्र क्रमांक 23/823/2022/13/1 दिनांक 04/01/2023 से आयोग कार्यालय हेतु तीन पदों का अनुमोदन प्राप्त हुआ है, उक्त स्वीकृत पदों को विनियम में सम्मिलित करने हेतु संशोधन की आवश्यकता अनुभव की गई, आयोग एतद् द्वारा राज्य शासन के अनुमोदन से निम्नलिखित विनियम बनाता है, अर्थातः—

**छत्तीसगढ़ राज्य विद्युत नियामक आयोग (अधिकारियों एवं कर्मचारियों की नियुक्ति एवं सेवा शर्तें)
(द्वितीय संशोधन) विनियम-2023**

1. संक्षिप्त नाम तथा प्रारंभ:

- (1) इस विनियम का संक्षिप्त नाम छत्तीसगढ़ राज्य विद्युत नियामक आयोग (अधिकारियों एवं कर्मचारियों की नियुक्ति एवं सेवा शर्तें) (द्वितीय संशोधन) विनियम, 2023 है।
- (2) यह विनियम छत्तीसगढ़ राजपत्र में प्रकाशन की तारीख से प्रभावशील होगा।
- (3) इस विनियम में उपयोग किए गए अन्य सभी शब्द और अभिव्यक्तियाँ, जो इस विनियम में परिभाषित नहीं हैं, उनका वही अर्थ होगा जो छत्तीसगढ़ राज्य विद्युत नियामक आयोग (अधिकारियों एवं कर्मचारियों की नियुक्ति एवं सेवा शर्तें) विनियम, 2005 में है। (आगे मूल विनियम के नाम से संदर्भित)

2. परिशिष्ट-1 में संशोधन — मूल विनियम के परिशिष्ट-1 को परिशिष्ट-1 से प्रतिस्थापित किया जाता है।

NOTIFICATION

No.105/CSERC/2023.— In exercise of the powers conferred under clause (zk) of Sub-section (2) of Section 181 read with Section 91 (2) & (3) of the Electricity Act, 2003 (No. 36 of 2003) (the Act), and with the approval of the Government of Chhattisgarh, the Chhattisgarh State Electricity Regulatory Commission (CSERC) made regulations namely Chhattisgarh State Electricity Regulatory Commission (Recruitment and conditions of service of officers and employees) Regulations, 2005. Energy Dept., Govt. of Chhattisgarh vide letter No. 23/823/2022/13/1 dated 04.01.2023 has approved three posts for the Commission's Office. Considering these three posts, certain amendments have become necessary and therefore, the CSERC hereby makes the following regulations, with approval of the State Govt., namely: -

Chhattisgarh State Electricity Regulatory Commission (Recruitment and conditions of service of officers and employees) (Second Amendment) Regulations, 2023

1. Short Title, Definition and Commencement

- (1) These Regulations may be called the Chhattisgarh State Electricity Regulatory Commission (Recruitment and conditions of service of officers and employees) (Second Amendment) Regulations, 2023.
- (2) They shall come into force with effect from the date of their publication in the official Gazette.
- (3) All other words and expressions used in this Regulation, but not defined, shall have the same meaning as is in the Chhattisgarh State Electricity Regulatory Commission (Recruitment and conditions of service of officers and employees) Regulations, 2005 (herein after referred to as the principal Regulation).

2. Amendment in annexure-I- Annexure I of the principal regulation, shall be substituted as in Annexure I.

3. Amendment in annexure-II – After Annexure – II heading, following is added “See Principal Regulation Rule 7(3)”

4. Amendment in annexure-III – After Annexure – III heading, following is added “See Principal Regulation Rule 7(5)”

5. Amendment in annexure-IV- In annexure IV of the principal regulation shall be substituted as in Annexure IV.
