Sahu for the respondent CSPDCL.</p> <p>2. During the hearing, the Commission questioned the Respondent as to why it had not complied with the order passed by the Bilaspur CGRF. The Respondent CSPDCL submitted that, there was some confusion regarding the interpretation and applicability of the relevant Regulations. The Commission expressed its displeasure and observed that, if the Respondent was facing any such difficulty regarding the interpretation or implementation of the applicable Regulations, it ought to have approached the Commission on its own for appropriate clarification.</p> <p>3. The Respondent further submitted that the Learned Electricity Ombudsman has taken cognizance of the matter and that the case is reserved for orders.</p> <p>4. The Respondent is bound to comply with the order passed by the CGRF, and any difficulty in its interpretation or implementation cannot justify non-compliance. The Respondent is, therefore, directed to submit either a copy of the latest order passed by the Learned Electricity Ombudsman or submit a compliance report with respect to the order passed by the Bilaspur CGRF, before the next date of hearing.</p> <p>5.
