The Commission once again expressed its displeasure over the fact that the respondent had not submitted the compliance report till date. The respondent submitted that the learned CGRF had directed it to issue the bill under Regulation 8.6 of the Supply Code; however, the same was not feasible through the SAP system, and therefore, the billing was required to be undertaken under Regulation 8.7. The Commission found the said ground to be unjustified and asked the respondent why a manual billing could not be issued in the present case.</p> <p>5. The respondent is directed to comply with the order passed by the learned CGRF in its entirety and submit the compliance report to the Commission within a period of four (04) weeks. In the event of failure to do so, the Commission shall be constrained to impose penalty under Section 142 of the Electricity Act, 2003.</p> <p>6.
